In accordance with section 418.016 of the Texas Government Code, on March 16, 2020 Governor Abbott has suspended some provisions of the Open Meetings Act in response to the COVID-19 emergency. Lone Oak Economic Development meetings will not be open to on-site visitors. Abbott suspended certain open-meeting statutes to facilitate social distancing in public meeting. The Governor has carved out certain provisions within the suspended statutes to maintain government transparency and continued government operations while reducing face-to-face contact.
